Cool off this summer at the Gloucester Township Pool! Our memberships are inexpensive and will keep your family entertained all summer long.

The Twp. also has several new businesses and eateries open. Plus, the new shopping areas along Cross Keys Road are open! The Gloucester Town Center (Acme and Shops), Town Square Plaza (Target, Lowes, and other shops and restaurants), Twin Crossings Plaza (Roger Wilco and stores), Megha (Dunkin Donuts and stores), and CrossKeys Center (PNC Bank and stores) are all going strong. The Shoppes at Cross Keys recently opened as a destination with a variety of stores and eateries.

TOWNSHIP BUDGET ISSUES AND TAX BILLING State Procedures Slow Budget and Bills

The Township's Fiscal Year 08/09 Budget was finally adopted on April 6, 2009, after several months of delays by the State. The State did not finalize their tax relief plans for fiscal towns until late March.

After the hearing at the State Local Finance Board attended by Mayor Rau-Hatton, the Administrator, and Police Chief, the State did not grant any Extraordinary Aid this year to the Twp. The only relief for the budget is the "deferred pension payment" as set forth by the Legislature in March. This is to be paid back in the future.

Estimated tax bills were sent in January for the February payment. The May quarter tax bills reflect the approved FY08/09 Budget. The total increase in the local rate is .21. This increase has been spread only in the Feb and May payments (rather than across 4 quarters).

Tax Bills for the second half of the year (final billing for the schools, County and fire companies and estimated for the Township) will go out in July as normal. It is anticipated the Aug and Nov payments will be less than the Jan and Feb payments due to a decrease in school tax rate.

MAYOR'S CORNER

Spring is upon us! The warm weather allows our residents to enjoy the numerous parks, fields and the bike trail. I ask everyone to "pitch in" to keep the roads and parks free from litter. Organizations can call my office for

cleanup projects "Adopting a Highway". Public Works will supply the gloves and trash bags. Together we can keep our community clean. We also need to reduce our trash costs. Recycle containers are at all ballfields and parks. Please keep recyclables separate from regular trash it saves tax dollars!

It's been a difficult budget year. We experienced significant loss of State Aid and declining revenues due to the economy. Nine months after the beginning of the budget year, the State scheduled us for the Local Finance Board for review and approved our cap waiver. We were able to reduce the preliminary .24 tax rate increase to .21 by using the newly-legislated "pension deferment" as required by the State. However, the State denied our request for extraordinary aid, which resulted in a total loss of \$1.1 million in State Aid.

Council approved the final budget on April 6 at a .21 tax rate increase. The Budget showed little increase in spending from the previous year, mostly due to contractual obligations. Our biggest problem is the lack of revenue sources, including loss of \$1.1 million in State Aid, no liquor license sales, declining permit fees, and the non-sale of the Nike sites. The Municipal tax is 21% of your total tax bill.

I am working diligently to hold the line on our expenses while still providing essential services. We have reduced employee staffing due to attrition and Council implementing a hiring freeze. With employees already on a four-day (10 hour day) work week from many years ago, we have closed the municipal building on Fridays, to consolidate the remaining staff and made the departments more efficient. We also saved on overtime, as well as on energy costs. Senior services, Recreation, and Police are not affected. The hours of operation (8 AM-5:45 PM) are more effective and convenient for the public.

Construction is underway on the Berlin-CrossKeys Road/Expressway overpass. Winslow Mayor Metzner and I have worked hard to get this project from the table to the field. I thank the State, the County, and the S.J. Transp. Authority for their collective efforts for making this project a reality. Even though this construction period will be an inconvenience, it will be a great asset to the traffic flow and ease congestion. Check www.glotwp.com for traffic alerts and updates.

The Shoppes at Cross Keys will open in May, and will provide over 400 new jobs. This project, along with the other existing businesses in the area, will provide a boost to the local economy and great shopping opportunities for Gloucester Township residents and the region.

As per Township Ordinance, branches, hedge trimmings, light brush clippings, etc...must be securely tied into three foot (3') bundles that can be easily handled and the diameter of any branch may not exceed six inches (6"). Said bundles shall not exceed fifty (50) pounds in weight. Public Works will pick up bundles on your designated day only if the ordinance is followed.

TRAFFIC SAFETY UNIT

Berlin Cross Keys Road Bridge Expansion

Starting in April 2009 the expansion of the Berlin-Cross keys Road Bridge at the Atlantic City Expressway is scheduled to begin. This construction is expected to last until Dec. 2009. During the first phase of the construction Berlin-Cross Keys Road @ the AC Expressway will be closed to all vehicular traffic for a period of 5 days to allow for raising of the bridge. Detours will be in place during this time period. Motorists are advised

to seek alternate routes and delays are expected during construction. Info about the construction and dates of the detour and the routes can be found at www2.sjta.com.

New Law 39:4-92.2 Motorists Approaching Stationary Authorized Emergency Vehicle

The operator of a motor vehicle approaching an authorized emergency vehicle that is displaying a flashing, blinking or alternating red or blue light, or approaching an emergency service vehicle or tow truck displaying a flashing yellow, amber, or red lights shall approach the vehicle with due caution & shall absent any other direction by law enforcement officer proceed as follows; make a lane change into a lane not adjacent to the emergency vehicle, service vehicle or tow truck If a lane change would be impossible, prohibited by law or unsafe, reduce the speed of the vehicle to a reasonable and proper speed for the existing road & traffic conditions, which shall be less than the posted speed limit & be prepared to stop.

A violation would carry a fine between \$100 & \$500 and 2 motor vehicle points being assessed to the driver's license.

Highway Use Applications

Highway Use Applications must be filed with the Gloucester Twp Police Dept. for any roadway charitable solicitation event such as roadside hoagie sale, roadside coin drop or other roadside charitable events. Highway use applications must also be filed for residents requesting to hold a community block party on any street within the twp, & for residents wishing to place a roll off dumpster on any street within the twp.

Applications for roadside charitable events should be submitted at least 45 days prior to the event. Applications for community block parties should be submitted at least 20 days prior to the requested event. Applications for Roll off dumpsters should be submitted at least 10 days in advance. The Highway Use Application package contains the criteria & guidelines for solicitation events, community block parties, & roll off dumpsters. The application packages are available at the Gloucester Twp. Police Dept. & the Clerk's Office during business hours.

NJ HELMET LAW

Bicycle-Skateboard-Roller Skate Helmet Law: New Jersey Law 39:4-10.1 and 39:4-10.5

This Law require persons under 17 years of age to not operate a bicycle, skateboard or any roller skate unless they are wearing a properly fitted and adjusted helmet which meet specified standards. A parent or guardian of the violator may be fined up to \$100.

OPERATION OF MOTORIZED RECREATIONAL VEHICLES

The operation of motorized scooters, mini bikes, trail bikes, go-peds and other similar motorized vehicles recreational devices, electric or gas powered, are prohibited by Gloucester Township Ordinance 82-1 from being operated:

On private property without written consent of the property owner in their possession while operating the recreational device

On any public, municipal, or board of education grounds or property

On any public sidewalk or street or area dedicated commonly used for pedestrians or vehicular traffic

On any common area, parking area or open space of any apartment complex, multi family, residential, industrial complex or development

In a manner to create loud, unnecessary or unusual noise so as to disturb or interfere with the peace and quiet of other persons and no person shall operate such unlicensed motor driven or motorized vehicle before 9am within 500 feet of any residential property line.

Violators may be charged in violation of L.O. 82-1 and New Jersey Motor vehicles laws, which also prohibit the use of these recreational vehicles on public roadways.

CHILD SAFETY SEAT CHECKPOINT

Gloucester Twp Police Dept. in conjunction with Safe-Kids will be holding a child safety seat check point on June 6, 2009 at the Target Store on Berlin-Crosskeys Rd. This program is to assist parents in properly installing child safety seats. Times to be announced.

CODE ENFORCEMENT NEWS

As the weather gets warmer, closer attention needs to be paid to the exterior of your residence. High grass and weeds must be maintained and all trees and bushes must be kept trimmed. These violations are listed under the "Property Maintenance Code" located in Chapter 67A. The Code Enforcement Office looks forward to working with the residents of Gloucester Township as an effective means to help improve your neighborhood and community. Contacting code Enforcement is an easy way to help keep the township clean and to prevent potential disputes with neighbors who may not be adhering to the Township code. Code Enforcement Violations can be reported to the Code Enforcement Unit at 856-374-3513 or codeenforcement@glotwp.com.

Some of the most common violations:

Chapter 67A "Property Maintenance"- Residents are required to keep their property maintained at all times. The exterior of properties are to be properly maintained, such as repairs, and/or painting of house, garage, down spouts, etc., replacement/repairs of broken windows, fences, and sheds. Grass cannot exceed 10" in height and must be cut and maintained during the growing season. Bushes/shrubs must also be maintained (Trimmed and kept from becoming overgrown). Bushes/Shrubs also must not impede the sidewalk. Scattered trash/debris is not permitted and must be removed.

Chapter 75,8C "Swimming Pools" Disposal and Treatment of water: All pool water must be treated to avoid stagnant water and mosquito problems, also all pools require a fence around the pool area.

Land Development Ordinance Section 513 Signs

The following requirement shall apply to all signs:

No sign other than traffic control or similar official government signs shall be erected within or project over the right-of-way of any public street or sidewalk, except as hereinafter provided. Any sign located along the right-of-way of a State or Federal highway shall comply with any more restrictive requirements of the State & Federal government. Any sign installed or placed on public property, except in conformance with the requirements of this section, shall be forfeited to the public & subject to confiscation. In addition to other remedies that may be imposed under this Ordinance, the municipality shall have the right to recover from the owner or person placing such sign the full costs of removal and disposal.
