ORDINANCE OF VACATING A PORTION OF MELBOURNE LANE, LOT 27 AND LOT 17 WHICH IS TO BE CONSOLIDATED TO BECOME NEW LOT 17, IN THE TOWNSHIP OF GLOUCESTER, COUNTY OF CAMDEN, STATE OF NEW JERSEY

Mayor Mayer welcomed Boy Scout Troop 811 to the meeting. He stated that the scouts are visiting as they are working on merit badges while attending the meeting. Mayor Mayer stated that this weekend is Make A Difference Day and everyone will be working in the community park. He also stated that there will be a Halloween Party in the Recreation Center and a Ghost seminar at the Gabriel Davies Tavern. Mayor Mayer also thanked Mainstage and everyone who worked on the Pumpkin Festival.

Mayor Mayer stated that he also wanted to address the Disc Golf proposal at the Timber Creek Park. He stated that there is a proposal for Disc Golf at the Timber Creek Park. He stated that the plan he viewed was using the lower end of the dog park. He stated that his concern was that it was encroaching on some of the sensitive areas of the park. He stated that a balance must be struck, giving recreation to the township while also protecting the natural resources of the park.

He stated that there are some areas of the Timber Creek Park that are conducive to this type of recreation. He stated that this is a county park and it would be a decision that they have to make. A resident asked the Mayor how he communicated this with the County. Mayor Mayer stated that it was a verbal communication.
